Requesting issuance of necessary instructions to concerned Land Revenue Offices & Sub-Registrar Offices for marking encumbrance and not to effect the registrations/sale/mutations etc. of the properties of M/s PACL Limited, its group and subsidiary companies in terms of

Hon'ble Supreme Court's Order dated 02.02.16.

This is with reference to the meeting held on 06.10.2023 at your office between your goodself, the undersigned and DGM Shri Abhishek Khandelwal from Indore Local Office of SEBI, as advised by the Chief Secretary, Madhya Pradesh wherein your intervention was sought by the undersigned so as to ensure marking of encumbrance against a total of 5,566 properties of PACL Limited (hereinafter referred to as "PACL") so as to protect these properties from being transferred to third parties, thereby protecting the interest of investors of PACL.

2. In this context, your attention is drawn to letter dated 05.10.2023 (Annexure A), written to the Chairman, State Level Coordination Committee, Madhya Pradesh. As stated in the aforementioned letter, vide Order dated 02.02.2016 (Annexure B) of the Hon'ble Supreme Court of India, SEBI was directed to

constitute a committee under the Chairmanship of Justice (Retd.) Shri R.M. Lodha, former Chief Justice of India ("Committee") to dispose of the properties of PACL so that the sale proceeds can be paid to the gullible investors, from whom such funds were illegally collected by PACL.

- 3. Subsequently, Hon'ble Supreme Court of India, vide an order dated 25.07.2016 (Annexure C) inter alia restrained PACL and/or its Directors/ Promoters/agents/employees/group and/or associate companies from selling/ transferring/ alienating any of the properties wherein PACL has, in any manner, a right interest situated either within or outside India.
- 4. In accordance with above, the Committee has initiated the process of directing various land revenue authorities/Sub-Registrars in order to mark encumbrance over the properties identified to be held by PACL or its connected entities. It is seen that the said directions have been implemented in a number of states. However, based on online web search for current encumbrance status for sample properties from a list of 5,566 properties situated in the state of Madhya Pradesh, it appears that only one property has been marked as encumbered in favour of PACL Committee and no encumbrance in favor of the PACL Committee has been marked with respect to rest 5,565 properties as on date. In this regard, a list of a total of 5,566 properties along with their Survey/Khasara No. and name of buyer (who are associated with PACL) is placed in a CD, attached with this letter at Annexure D wherein encumbrance has been marked in land records of property at S. No. 1. For your ready reference, one sample title deed (which bears the seal of PACL Committee) is also annexed herewith in CD as Annexure E for your information, reference and doing needful.
- 5. You may appreciate that non-marking of encumbrance in the land records may not only delay the process of disposal of assets by the Committee but also

result in general public dealing in such properties believing that property is free from all the encumbrances and has clear and marketable title in favor of the Seller.

- 6. In this context, it is pertinent to bring to your kind notice that there are media reports and instances where properties of PACL are being sold illegally as no encumbrance is marked over these properties. The Committee has taken serious note of the above fraudulent activities and has issued public notice (Annexure F) cautioning intending buyers/public investors/public against buying and/or dealing with the properties of PACL Ltd. Therefore, there is an urgent need of your kind cooperation and timely intervention to facilitate the committee by ensuring that all identified properties are appropriately encumbered in land records.
- 7. In view of above, we request your kind interventions to ensure that encumbrance is marked against each of the 5,565 properties (Annexure D) and the updated encumbrance records are visible on official website displaying such information. Further, in cases where there has been any transfer of the title of said properties post issuance of Hon'ble Supreme Court Order dated 02.02.2016, your good office is also requested to initiate necessary actions towards restoring the title back as it was on the date of 02.02.2016.
- 8. In this regard, it is noticed that certain challenges have been faced by Collector, Sehore during marking of encumbrance over the properties of PACL within his district which were intimated to us vide letter dated 19.06.2023 (Annexure G). The same has been forwarded to PACL Committee for their further guidance on this issue. In case any challenges of this kind or of any other kind are being faced by your office in carrying out the exercise of marking of encumbrance over the aforementioned properties or if any clarification is needed, you are requested to contact the undersigned (dilipbj@sebi.gov.in) or

- The Hon'ble Supreme Court, vide its Order dated 02.02.2016 (Annexure A) directed SEBI to constitute a committee under the Chairmanship of Justice (Retd.) Shri R.M. Lodha, former Chief Justice of India ("Committee") to dispose of the properties of PACL Ltd. (hereinafter referred to as "PACL") so that the sale proceeds can be paid to the gullible investors, from whom such funds were illegally collected by PACL.
- 2. Subsequently, Hon'ble Supreme Court of India, vide an order dated 25.07.2016 (Annexure B) inter alia restrained PACL and/or its Directors/Promoters/agents/employees/group and/or associate companies from selling/transferring/alienating any of the properties wherein PACL has, in any manner, a right interest situated either within or outside India.
- 3. In accordance with above, the Committee and SEBI have done multiple follow ups with various land revenue authorities/Sub-Registrars in order to mark encumbrance over the properties identified to be held by PACL or its connected entities (List A). While Inspector General of Registration and the Commissioner, Land Records have issued directions to mark encumbrance over PACL properties, based on online web search for current encumbrance status for sample properties from a list of 5,566 properties situated in the state of Madhya Pradesh, it appears that no encumbrance in favor of the PACL Committee has been marked as on date. A list of these 5,566 properties (duly affixed by PACL Committee) along with their Survey/Khasara No. and name of buyer (who are associated with PACL) is annexed herewith as Annexure C.
- 4. It may be noted that the Committee has received claims from 1.5 crore investors for an amount of Rs 28,734 crores. Out of these applications, claim in respect of 19.62 lakh applications amounting to claim of Rs 919.91 crores has been refunded, after sale of certain properties of PACL. The process of disposal of assets and refund to investors in ongoing.

In this context, it is pertinent to bring to your kind notice that there are media reports and instances where properties of PACL are being sold illegally as no encumbrance is marked over these properties. C.A.Nos.13301, 13319, 13394 & 13410 of 2015, WP(C) No.500/2015, T.C.(C)No.134/2015 :

- 1. Heard Mr. C.A. Sundaram, learned senior counsel appearing for the appellant-Company, Mr. Anil B. Divan, learned senior counsel appearing on behalf of the Director of the Company and Mr. Arvind P. Datar, learned senior counsel appearing on behalf of Securities & Exchange Board of India (SEBI), on caveat.
- 2. Upon hearing the learned counsel and looking at the peculiar facts of the case, in the interest of the investors, we think it proper to pass this order with regard to interim arrangement, without going into the legality of the impugned judgment and without prejudice to the submission which might be made by the counsel at the time of further hearing of these matters and we direct that the appellant-Company shall not collect any

further amount from any of the investors.

- 3. The SEBI shall constitute a Committee for disposing of the land purchased by the Company so that the sale proceeds can be paid to the investors, who have invested their funds in the Company for purchase of the land. Hon'ble Mr. Justice R.M. Lodha, the former Chief Justice of India, would be the Chairman of the said Committee. It would be open to the Hon'ble Chairman of the Committee to appoint such experts or other persons, as he might think it necessary, in consultation with the SEBI, so as to enable the Committee to sell the land and pay to the investors in a manner that might be decided by the said Committee.
- 4. A Nodal Officer shall be appointed, who shall be in-charge of the funds so collected and shall have a liaison with the Committee and shall also work as a Secretary to the said Committee.
- 5. The Committee shall collect relevant record, including Title Deeds from the Central Bureau of Investigation (CBI), if the CBI is in possession of any of the documents. Copies of the Title Deeds shall also be given to the Company so that the Company can also assist the Committee in the process of sale of the land.
- 6. The CBI is directed to hand over the documents, after retaining their copies, which might be required by the SEBI, so as to enable the Committee to sell the land.

The CBI will be entitled to use the photocopies of the Title Deeds, which will be handed over to it for Court proceedings.

- 7. The methodology with regard to recovery of amount by sale of the land and disbursement of the amount to the investors shall be overseen by the Members of the Committee.
- 8. Remuneration to be paid to the Chairman shall be determined by the Hon'ble Chairman himself after considering the quantum of work to be done by the Committee.
- 9. The work with regard to disposal of the land and disbursement of the proceeds to the investors be completed as soon as possible and preferably within six months from today.
- 10. The Registry is directed to forward copies of this order to Hon'ble Mr. Justice R.M. Lodha, the SEBI and the CBI. The Company and its Directors shall extend their cooperation to the Committee so that the Committee can function effectively to complete the work as soon as possible.
- 11. It would be open to the Hon'ble Chairman to make modification in the afore-stated arrangement and he is empowered to do whatever he thinks proper for disposal of the land and disbursement of the proceeds to the investors.

- 12. The amount, which is lying in the bank accounts of the Company and other cash belonging to the Company shall be released in favour of SEBI so that it can be used either for disbursement in favour of the investors or for incurring necessary expenditure. If any amount has been deposited by the Company or by its Directors or by any other person on behalf of the Company in any Court, the same shall be released in favour of the SEBI, who shall have a separate account so as to deal with the same. The Committee shall also decide as to whether the staff of the Company should be continued or relieved.
- 13. The decision with regard to sale of property of the Company by the Committee shall not be interfered with by any Court.
- 14. List the matters on 2^{nd} August, 2016 as Part-heard, so as to know the progress.

- 4. Whereas the Hon'ble Supreme Court by order dated 25.07.2016 restrained PACL Ltd. and/or its Directors/ Promoters/ agents/ employees/Group and/or associate companies from selling/transferring/alienating any of the properties wherein PACL has, in any manner, a right/interest whether situated within or outside India.
- 5. Whereas PACL Limited had by its letter dated August 08, 2016 admitted having purchased lands in the name of its group/associate companies named in the annexure and majority of title deeds so far submitted by CBI to the Committee are held in the name of group/ associate companies and very few documents are in the name of PACL.
- 6. It is observed that the amount to be recovered, including the principal amount and the promised returns, further interest etc. would be more than Rs 55,000 Crores. The Hon'ble SAT while dismissing the appeals filed by the company had observed in Para 49 (j) that "Admittedly, value of the total lands held by PACL in the form of stock in trade as on 31.03.2014 was Rs. 11,706.96 crore."
- From the above, it is prima facie observed that the money mobilised by PACL in violation of SEBI (CIS) Regulations, 1999 is diverted the money to its group companies, associates and individuals.
- 8. In order to protect the interest of the investors in PACL Limited and to ensure compliance with the directions of the Hon'ble Supreme Court, it is necessary to protect the money transferred by PACL to its associate entities, the properties purchased out of the money mobilised by PACL limited and those purchased by PACL Limited in the name of its group companies, associates and individuals from alienation.


